- (ii) That Launcelot HENDERSON and William WALDEGRAVE be re-elected to a Fellowship under Statute III, cl. 11 (Distinguished Fellowship, tenable by 'any person who, having been a Fellow, has attained distinction in the service of the Crown, in the profession of the law, or in literature, science, art, education, or public affairs').

3. ADVERTISEMENT OF POST-DOCTORAL RESEARCH FELLOWSHIPS

The College resolved to advertise that it intends to elect six Post-Doctoral Research Fellows (Statute III, cl. 3) in 2023 – two in Life or Environmental Sciences, and one in

each of: History since 1800; History of Art or Music or Science; Mathematics; and Social Anthropology – provided that there are candidates of sufficient merit.
