3. ELECTIONS TO FELLOWSHIP

The College formally resolved:

- (i) That, according to the recommendation of the Academic Purposes Committee, at the December Stated General Meeting Santanu DAS should be re-elected to a Senior Research Fellowship under Statute III, cl. 5 with effect from the expiry of his current term of Fellowship on 31 December 2025 for a further seven years.

- (ii) That Lucia PRAUSCELLO be re-elected to a Senior Research Fellowship under Statute III, cl. 5 with effect from the expiry of her current term of Fellowship on 30 September 2025 for a further seven years.
- (iii) That Gavin SALAM be re-elected to a Senior Research Fellowship under Statute III, cl. 5 with effect from the expiry of his current term of Fellowship on 30 September 2025 for a further seven years.
- (iv) That Rachel CARNEGIE be re-elected to a Fellowship under Statute III, cl. 9 (College Officer) for seven years with effect from 2 November 2025. The Notice was circulated with the recommendation of the General Purposes Committee meeting of 8 March 2025. The Chaplain's election to Fellowship in 2024 was for an initial one-year period, with renewal subject to mutual agreement.
- (v) That, with effect from 2 November 2025, Julia MOORE be elected to a Fellowship under Statute III, cl. 2(iii) (Research) until the expiry of her Examination Fellowship in 2030. She will complete her DPhil and spend the remainder of her Fellowship turning it into a monograph. The details of this project are set out in her letter of application.
- (vi) That, with effect from 2 November 2025, Augustus SMITH be elected to a Fellowship under Statute III, cl. 2(iii) (Research) until the expiry of his Examination Fellowship in 2030. He will complete his DPhil and spend the remainder of his Fellowship turning it into a monograph. The details of this project are set out in his letter of application.
- (vii) That David ADDISON be elected to a Fellowship under Statute III, cl. 10 (Fifty-pound Fellowship) for a period of seven years with effect from 15 June 2025.
