### 1. APPOINTMENT OF COLLEGE OFFICERS

The College approved the appointment of College Officers for the academic year 2023–24.

### 2. FELLOWSHIP ELECTIONS

Further to the recommendations of the General Purposes Committee and Academic Purposes Committee, the College resolved the following:

- (a) That Matan MAZOR be elected to a Fellowship under Statute III, cl. 3 (Post-Doctoral Research Fellow).
- (b) That Ruth HARRIS, Noel MALCOLM, Ian RUMFITT, and Lucia ZEDNER be re-elected to a Senior Research Fellowship under Statute III, cl. 5.
- (c) That the Fellowship of Peregrine HORDEN (Statute III, cl. 9 (College Officer) as Fellow Librarian) be extended by one year to 30 September 2024.

### 3. ADVERTISEMENT OF SENIOR RESEARCH FELLOWSHIPS

The College resolved to advertise that it intends to elect two Senior Research Fellows (Cl. 5) in 2024—one in History since 1500 and one in Life or Environmental Sciences—provided that there are candidates of sufficient merit.
